

There are some good ideas here, and it shouldn't be hard to get your money's worth from the book. The CD provides electronic / printable copies of forms, which may be handy.But it's not likely to really provide a complete set of answers for you. It's a very brief book, and presents just the approach the author's family uses at their cottage, without any discussion of alternatives or much explanation of why they use that approach. So it's not likely to provide a complete solution to how to manage your cottage. For example, their system for reserving time provides that the "partners" (the four siblings, in this case) can bump the adult children of the next generation up to 14 days before a booking. That could be a disaster in lots of families, causing a lot of resentment. There are other approaches. But there's no discussion of potential issues or alternatives. Similarly, the lists and forms likely aren't quite going to fit your needs or situation, though they would likely be a good starting point if you want to customize something. The style is quite personal - take advantage of 's "Look inside this book" feature by clicking on the image of the book, have a look to see if the book seems likely to be something you would enjoy using. You may want to consider Saving the Family Cottage: A Guide to Succession Planning for Your Cottage, Cabin, Camp or Vacation Home instead of, or in addition to, this book. So there are some good ideas, and it will get you thinking. Just don't expect a complete solution, since one size definitely does not fit all for this sort of thing!
