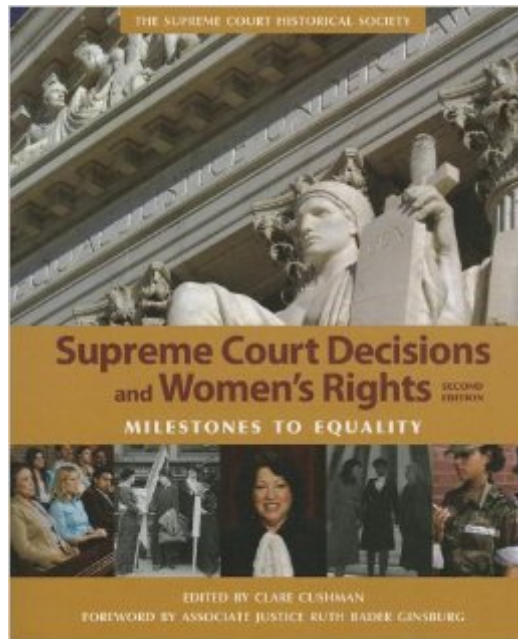

The content of the book is so-so. Each chapter focuses on a handful of landmark Supreme Court cases to discuss society's attitude about women and their rights for that time period. Unfortunately, the writers jumped around the opinions and it's easy to confuse which opinion belonged to which case if you're not intimately familiar. Ultimately, I would say to read the index of cases for each chapter and then read the actual cases; forego the book and don't waste your time. The seller was great, though.
